**RESOLUTION APPOINTING WILLIAM E. ANTONIDES, JR. AS INTERIM
TOWNSHIP ADMINISTRATOR AND RELATED ACTIONS**

WHEREAS, pursuant to N.J.S.A. 40A:63-6(c), the executive responsibilities of the Township are placed in the Township Committee; and

WHEREAS, pursuant to N.J.S.A. 40A:9-136 et seq., N.J.S.A. 40A:63-7(a), and Holmdel Township Ordinance § 2-5, the Township Committee delegates portions of this executive responsibility to the position of Township Administrator; and

WHEREAS, the position of Township Administrator is currently vacant and is being filled on an interim basis by an individual from an external consulting firm pursuant to Resolution 2022-78; and

WHEREAS, the Township Committee has determined that, moving forward, it is in the best interests of the Township for the position of Township Administrator to be filled on an interim basis by a current internal employee of the Township; and

WHEREAS, current Township Chief Financial Officer William E. Antonides, Jr. has agreed to assume the position of Interim Township Administrator; and

WHEREAS, in order to perform the duties of both Interim Township Administrator and Chief Financial Officer, Mr. Antonides will require additional support services from current employees of the Township; and

WHEREAS, the Township Committee seeks to appoint the appropriate personnel to stipends to cover the amounts of hourly work that are currently being performed by the external consulting firm.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Holmdel, as follows:

1. The foregoing recitals are hereby incorporated as if set forth at length.
2. William E. Antonides, Jr. is hereby designated as Interim Township Administrator and is authorized and directed to exercise all of the powers afforded to the Township Administrator pursuant to law. Mr. Antonides shall be compensated at the rate of \$125 per hour for work performed as Interim Township Administrator, at a minimum and anticipated total of ten (10) hours per week.
3. Barbara Kovelesky is hereby designated as an Assistant to the Township Administrator on an as-needed basis. Ms. Kovelesky shall be compensated at the rate of \$50 per hour for work performed as an Assistant to the Township Administrator, at a minimum and anticipated total of ten (10) hours per week.

4. Tara Buss is hereby designated as an Assistant to the Township Administrator on an as-needed basis. Ms. Buss shall be compensated at the rate of \$50 per hour for work performed as an Assistant to the Township Administrator, at a minimum and anticipated total of ten (10) hours per week.
5. Resolution 2022-78 is hereby repealed to the extent it is inconsistent with the terms of this Resolution.
6. The provisions of this Resolution shall remain in full force and effect unless and until a new Township Administrator is appointed by the Township Committee pursuant to law or further action is taken by the Township Committee modifying the provisions of this Resolution.
7. This Resolution shall take effect immediately.
8. The Township Attorney is hereby authorized and directed to take any and all steps reasonably necessary to effectuate the foregoing.
